TABLE KEY

F/R: Percentage of students in school or district eligible for free or reduced-price (F/R) meals based on reports from October 2014.

% F/R Students Participating in SBP: The number of students on a free or reduced-price (F/R) meal plan that ate School Breakfast (SBP) each day for every 100

Rank: The order, from highest participation to lowest participation, schools and districts rank in school breakfast participation.

Additional Students Eating Breakfast: Number of additional students who would receive school breakfast at a free or reduced-price if the school was reaching 70 students at breakfast for every 100 students who received lunch at a free or reduced-price rate. The Food Research and Action Center has established that a successful School Breakfast Program is one that reaches 70 low-income students for every 100 low-income students who participate in the National School Lunch Program.

Additional Federal Funding: The amount of additional federal dollars schools and districts would have received in the 2014-2015 school year if students who are on a free or reduced-price meal plan participating in school lunch also participated in the district's School Breakfast Program.
